ADMINISTRATIVE STAFF REPORT

Subject: Division of Emergency Management
Hazard Mitigation Grant Program (HMGP)
Project Number – 4399-110 - R
Wastewater Collection System, Utility Mitigation

Subject Background: The City of Marianna was approved for HMGP funding for multiple projects. This project is for system hardening at the wastewater treatment plant (WWTP) Hillcrest Lift Station and the West Manor Lift Station.

Recommendation: City Staff and the City Attorney have reviewed the Grant Agreement and find it acceptable, subject to there being no substantive changes. It is recommended approving the Grant Agreement.
