City of Marianna Community Development Block Grant Program Hometown Revitalization Disaster Recovery Program First Public Hearing Notice

The City of Marianna is considering applying to the Florida Department of Economic Opportunity for a Community Development Block Grant Program Hometown Revitalization Disaster Recovery Program (CDBG-DR). The City is eligible to apply for a minimum of \$250,000 up to \$15,000,000 and must support a primarily commercial service area. Activities funded through the CDBG Program must meet one of the following National Objectives:

- Benefit low- and moderate-income (LMI) persons
- Aid in the prevention or elimination of slums or blight
- Meet a need having a particular urgency (urgent need)

The types of activities that CDBG funds may be used for include construction of streetscapes, lighting, sidewalks and other physical improvements; Acquisition, demolition, site preparation or rehabilitation of commercial structures carried out by the local government; assistance to small businesses for rehabilitation and physical improvements; and façade improvements to private and public structures in commercial areas.. Additional information regarding the range of activities that could be funded will be provided at the public hearing.

In developing a CDBG-DR application, the City of Marianna must plan to minimize displacement of persons as a result of the activities. In addition, the City of Marianna is required to develop a plan to assist displaced persons.

A public hearing to obtain citizen's comment concerning the City's disaster recovery and community development needs will be held at City Hall, 2898 Green Street, on January 5, 2021, at 6:00 PM or soon thereafter.
